CHAPTER 138, LAWS 1906.

AN ACT for the Enumeration of the ex-Confederate Soldiers of the State of Mississippi.

ENUMERATION OF CONFEDERATE SOLDIERS AND WIDOWS OF SOLDIERS TO BE MADE.

SECTION 1. *Be it enacted by the Legislature of the State of Mississippi,* That it shall be the duty of the Assessor of each county of the State to make a biennial enumeration of all the ex-Confederate soldiers and widows of deceased soldiers residing in his county, stating from what State they enlisted and in what regiment and company they served and age; beginning on the first Monday in February, 1907, and the enumeration is to be made within the time authorized by law for making the assessment and biennially thereafter.

AUDITOR TO PROVIDE ASSESSORS WITH BLANKS FOR SAME.

SEC. 2. Blanks for the enumeration shall be prepared by the State Auditor of Public Accounts, who shall furnish same to the County Assessors of the State, and the Assessors of the several counties shall make the enumeration, and for said enumeration they shall receive the same compensation as received for the enumeration of educable children; and the Chancery Clerk shall file a copy of the same in his office and send a copy to the Auditor of the State, to be filed in his office.

SEC. 3. That this Act take effect and be in force from and after its passage.
